ABOUT THE TRUST

The Shrewsbury and Telford Hospital NHS Trust (SaTH) is the main provider of acute hospital services for around half a million people in Shropshire, Telford & Wrekin and mid Wales.

Encompassing some of the most picturesque parts of England and Wales, the Trust's catchment stretches from the Cambrian Mountains in the west, to Newport and the fringes of the Black Country in the east.

The main towns include: Bridgnorth, Ludlow, Market Drayton, Oswestry, Shrewsbury and Whitchurch (in Shropshire); Newport, Telford and Wellington (in Telford & Wrekin); and Newtown and Welshpool (in Powys) – all beautiful and unique.

Our main service locations are The Princess Royal Hospital (PRH) in Telford and The Royal Shrewsbury Hospital (RSH) in Shrewsbury which are located 20 minutes drive apart. Together they provide 99% of our activity. Both hospitals provide a wide range of acute hospital services including accident & emergency, outpatients, diagnostics, inpatient medical care and critical care.

We also provide services such as consultant-led outreach clinics at Telford, the Robert Jones and Agnes Hunt Orthopaedic Hospital, Gobowen and the Bridgnorth, Ludlow and Whitchurch Community Hospitals.

We employ more than 6,000 people, and hundreds of colleagues and students from other organisations also work in our hospitals. We benefit from around 1,000 wonderful volunteers, and our main charitable partners are the League of Friends at The Royal Shrewsbury Hospital, Friends of The Princess Royal Hospital, and the Lingen Davies Cancer Appeal which is based at The Royal Shrewsbury Hospital.


JOB OVERVIEW

The post holder will work closely with the service leads to ensure efficient and effective management of all resources to deliver safe, high quality and effective clinical services in an environment of continuous improvement.

The post holder will work with other Divisions and Centres, as required, to deliver the Trust's overall strategic objectives, ensuring that the patient experience is a key priority.

MAIN DUTIES AND RESPONSIBILITIES

Service Delivery

• Have oversight of the delivery of Phlebotomy, Central Specimen Reception and PanPathology administration across all sites.

- To be the link for any day-to-day issues within Pathology stores and Pathology transport.
- To support with all HR and recruitment issues in all the above sections.
- Collect, collate, and report information, as required, ensuring that accurate patient

records/documentation are maintained, taking action to resolve problems.

• To contribute to the development of, and direct implementation of, operational policies which ensure compliance with UKAS, ensuring best practice.

• To ensure that relevant information on activity and performance is disseminated as appropriate throughout the area of responsibility to support effective decision making.

• To identify and address areas of concern, prepare and present options for improvement and implement change where required.

Finance

• To support the Scientific Lead & Lead BMSs in ensuring that services are delivered within agreed financial plans and budgets, including any agreed cost efficiency improvements.

- To support and advise the Scientific Lead & Lead BMSs in budget negotiations.
- To ensure that the Divisions assets and resources are used efficiently and economically.
- To contribute to efficiency improvement initiatives and plans.

• To identify and address areas of concern, ensuring that corrective action is taken in a timely manner where it becomes apparent that progress against plan is not as expected.

• To support the development of long-term strategies to ensure the financial sustainability of the area of responsibility.
